Eligibility Criteria: Candidates seeking admission to the Ph.D. in **Mool Shastra and Sampradaya Shastra, Bon Sampradaya, Restoration in Sanskrit, BhotJyotish, Bon Sampradaya, Sowa Rigpa, Fine Arts and Tibetan History** shall have to possess: Master's degree in Concerned/Respective subject with a minimum of 55 % marks (CGPA 5.5 on a 10point scale) or equivalent from a recognized University / Institution.

Application Procedure:

Candidates can download the Ph.D. application form through the University's web-site (www.cihts.ac.in). The prescribed application form duly filled up and accompanied with self-attested photocopies of all the relevant documents e.g. Marksheet, Caste Certificate etc. may be submitted to the office of the Registrar, CIHTS or addressed electronically to:- registrar@cihts.ac.in

Professionally employed personnel at CIHTS such as working researcher, teachers and other employees may be allowed to pursue Ph.D. after submitting "No Objection Certificate" from their parent organization / department / employer.

Admission Criteria:


Admission shall be based on:
