At the outset, the Chairman welcomed the august members- particularly, Madam Amita Sarbhai, Jt. Secretary, Ministry of Culture, New Delhi and Shri Harish Kumar, Director (IFD) Government of India, Ministry of Culture, New Delhi for attending the BoG meeting on Webinar in spite of other hectic schedules in the Ministry. He also thanked to Prof. K.T.S. Sarao, Prof. Amarjiva Locha and Geshe Lhakdor, Director (TWA) for participating in the virtual meeting of the BOG. He further thanked Prof. Lobsang Tensin and Prof. D.D. Chaturvedi for attending the meeting of the Board of Governors. He also expressed his extreme hope in the guidance of the luminaries, which would let the Institute usher into a new era of development and achievement.

Agenda Item No. 59.1 (i) Confirmation of the Minutes of the last(58th) meeting of the Board of Governors held on September 21, 2019 in the Committee Room of the Academic Building of the Institute at Sarnath, Varanasi.

During discussions on Minutes of the 58th Board meeting, Madam Joint Secretary stated about the amendments made by the Ministry in the Draft Minutes of the 58th BoG. The Board observed the contents of the related amendments made by the Ministry. It was "*in any case Dr. Upadhyay must be relieved from the charge of the Registrar, CIHTS before 30-06-2020 so as to enable him to superannuate from his substantive post in his parent organization i.e. BHU. Any further appointment of the persons will be considered afresh exercise undertaken strictly in accordance with the existing Recruitment Rules for the post of Registrar, CIHTS*". The Board noted the above amendment. Observing all pros and cons of the fact, the Board confirmed the 58th Minutes of the BoG treating the amendments as a part of the Minutes of the 58th Board meeting.

(ii) Confirmation of the Minutes of the Special Meeting of the Board of Governors held on 29th June, 2020.

The Minutes of the Special Meeting of the Board of Governors held on 29th June, 2020 were confirmed.

Agenda Item No. 59.2 Action taken/present position on the resolution of the Governing Body taken at its last(58th) meeting held on September 21, 2019.

The issue relating the case of Shri L.K. Mishra was discussed elaborately. The Chairman of the Board apprised the members about the whole scenario of the embezzlement made by Shri L.K. Mishra and thereafter action taken thereon. Madam Joint Secretary invited the attention of the Board stating that the penalty

imposed on the official does not commensurate with the gravity of the charge. The Chairman further clarified that Shri Mishra has been given compulsory retirement without his due promotion on the basis of the legal opinion taken on the report of the Inquiry Officer. He has gone to the Court and as such the matter is now Sub judies. Madam Jt. Secretary inquired about the amount already recovered and balance to be recovered. It was clarified by the Institute that as per the order, he was given a notice to deposit the amount of Rs. 18,57,000/-with interest @4% i.e. Rs. 32,95,908/-. Since Shri Mishra did not deposit the same, an amount of Rs. 15,40,066/- was recovered from his retirement benefits (Gratuity & Leave encashment) and he was informed that the rest amount i.e. Rs. 17,55,842 /- will be recovered from 7th CPC arrear and dearness relief.

With above observations the Board endorsed the action taken report.

**59.3.6 Engagement of Dr. Richard Tilakaratna as Visiting ,
Professor w.e.f. 01-01-2020 to 31-12-2020**

Prof. Amarjiva lochan expressed apprehension regarding the works of Dr. Richard Tilakaratna and enquired about his scholarship in the related field. He was also of the view that while engaging such Visiting Professors, the Institute should obtain the views of the academic members of the BoG like Prof. K.T.S. Sarao and himself as they could help in ascertaining the background & proficiency of the scholarship of such field of scholars. The Chairman clarified the doubts and also explained that he(Dr. Tilakratna) was here only for 2-3 months though agenda

stated that his engagement was for twelve month. During his period, the Institute started Diploma Courses in Pali language. Shri Harish Kumar, Director (IFD), Government of India, Ministry of Culture raised the question regarding whether proper Visa procedures had been followed in the case of Dr. Richard Tilakratna as it was not stated whether he was on teaching Visa/ or tourist visa. The Chairman stated that most probably he was on teaching visa. The BoG advised the CIHTS authorities regarding conforming to the laid down extant orders/guidelines & MEA clearance in such cases so as to ensure no undesirable activities gets permitted in the guise of visiting/guest faculty. The Chairman assured the Board that in future completion of required formalities will be ensured while engaging any foreign national. With this observation, the Board endorsed the engagement of Dr. Tilakaratna as Visiting Professor starting from January 7, 2020 to 23rd March, 2020.

**59.3.7 Re-engagement of Prof. Yeshi Thabkhey as Visiting ,

The Board discussed the re-engagement of Prof. Yeshi Thabkey as Visiting Professor w.e.f. 04-03-2020 for a year to work on Neyartha Neetartha Project and endorsed the same.

Item No. 1 Considering way of implementation for extending medical facilities to the employees of the Institute including pensioners.

The Board discussed the matter relating extension of medical facilities to the employees of the Institute and pensioners . The Board noted that the matter has already been discussed in the last meeting of the F.C. held on 1st October, 2020 and accordingly approved the recommendation of the F.C. in the matter.

The matter related to R.E. for the year 2020-21 and B.E. for the year 2021-22 was discussed elaborately. The Board noted that the matter has already been discussed in the last meeting of the F.C. held on 1st October, 2020 and accordingly approved the recommendation of the F.C. in the matter.

Item No. 3 To undertake project for translation of Pali Buddhist Canonical literature into Tibetan,

The Chairman apprised the Board members about the Project for translation of Pali Buddhist Canonical literature into Tibetan. He referred

the letter of Secretary to His Holiness, the Dalai Lama in which it is stated that it has been his holiness' long held wish to have translation of Buddhist Classical Treatises in Pali into Tibetan language. The Institute and Gaden Phodrang Office would together undertake this important project. However, the CIHTS have to prepare the project proposal and therefore the matter is before the Board for approval.

The Board discussed the project and approved it.

Item No. 4

Considering re-employment of Prof. D.R.Singh.

The Chairman apprised the Board that presently, there is only one teacher in Economics. Therefore, it would not be possible to meet out the required teaching load in the subject concerned. As per UGC rules, retired professors can be engaged on re-employment basis. Accordingly, the Institute constituted a Committee of experts to examine and report. The Committee has submitted its recommendation for re-employment (Contractual) for a period of 3 years in the Deptt. of Social Science. Further, the Committee has recommended to offer the emoluments equivalent to the last pay drawn minus pension as consolidated amount which will remain the same through -out the tenure of re-employment.

The Board discussed the matter and approved the re-employment of Prof. D.R. Singh as recommended by the said Committee adding therein that till the period of re-employment of Prof. Singh, no recruitment on the post be made.

Considering Minutes of the 30th Academic Council meeting held on June 30, 2020.


