A Walk-in-Interview is scheduled on **25.07.2022** from **3:30 P.M.** onwards for the appointment of Guest Faculty (Contract) in Nyingma (1 post), Department of Sampradaya Shastra for CIHTS, Sarnath, Varanasi in the Office of the Hon'ble Vice Chancellor.

### **Nature of Job:**

The job is purely temporary and on contract basis. The incumbent will have no claim for permanent absorption in the Institute in lieu of this engagement. Selected Candidate will be engaged as full-time contractual faculty at Department of Sampradaya Shastra for academic session 2022-2023. The incumbent may be terminated at any time without assigning any reason.

### **Essential Qualification:**

- (A) (i) A Master's degree with 55% marks in the concerned subject from an Indian University/ recognized Institution, or an equivalent degree from an accredited foreign university.
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. degree in concerned/ relevant discipline.

**OR**

Who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil/Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions: -

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph.D work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned

**OR**

**(B)** The Ph.D. degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following:

- (i) Quacquarelli Symonds (QS)
- (ii) The Times Higher Education (THE) **Or**
- (iii) The Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

**Salary:** Rs. 50,000/- per month (fixed)

**Hiring Procedure:** Interview followed by classroom teaching demonstration.
