Rajya Sabha Unstarred Question No. 806 for 27-07-2021 regarding " Policy for treatment of diseases through AYUSH reg.

- a) Whether Government is trying to develop India as a Global hub for treatment of diseases through AYUSH system;
- The Government of India recognized Sowa-Rigpa as Traditional Medical System in India in December, 2011, making it the most recent major medical tradition of health care system under Ministry of AYUSH.
- b) If so, the details thereof;
- The Sowa-Rigpa department of the Institute runs an Out Patient Clinic for consultation as well as dispensary, which provides Tibetan medicines that are formulated in the on site pharmacy. The cost of both consultation and medicine is minimum in order that these services can be accessible to everyone, regardless of their financial situation. This has proved popular with local Indian people as well as with CIHTS students , staff and foreigners who have benefitted from its treatment.
 - There is an on campus teaching garden-that contains over 100 plants and 30 species from the Trans-Himalayan belt. CIHTS also runs medical herbal farm located in the Tawang district of Arunachal Pradesh. Many rare and endangered species of plants of the high Himalayas, which are under threat due to ecological impact are being restored. In this way Sowa-Rigpa is playing an important role in medicinal plant conservation on one way on the other side there stands hope that the development of herbal crops can contribute to the socio-economic welfare of the regional committee.
 - The Sowa-Rigpa medicines are made in the Institute pharmacy, with strict attention to purity, timing, drying, treating, and preservation. In the Institute, the training of the Sowa-Rigpa doctors is done in alignment with current educational requirement and timelines. CIHTS offers Menpa Kachupa a Bachelor of Sowa-Rigpa Medicine and Surgery, a four and half year programme, followed by one year internship. In addition, CIHTS provides a three year, integrated Menrampa (Post Graduate Course) in the specialized field of Sowa-Rigpa.

c) The major policy initiative to popularize the treatment of various diseases through AYUSH system?

- The Sowa-Rigpa department has exciting plans in all areas of teaching, research and patient care, with further development and expansion of the four main departments: General Medicine and Surgery, Pediatrics and Gynaecology, Pharmacology and Pharmaceutics, and Research & Development.
- The R& D Unit of the Sowa-Rigpa department will further investigate the fundamental principles, identify effective therapeutic regimen, and establish systems for quality control and evidence-based treatment. A major research study into the identification and usage of Sowa-Rigpa herbs and plants is currently underway.
- The unit will also elucidate on some literature of Sowa-Rigpa while making some classical Ayurvedic texts available in the Tibetan language for the first time. In this vein, the department library will be further developed with the separate procurement of around ten thousand titles available in Tibet so as to share the intellectual heritage of Sowa-Rigpa tradition and to gather, document, and study available knowledge using the latest archival technologies.
- Further, the Govt. of India has accorded sanction of Rs. 45.91 crore for construction of 1st phase of Sowa-Rigpa Hospital and the construction of the Hospital is nearing completion and in very near future, it will be available for indoor patients seeking treatment through Sowa-Rigpa.

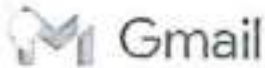

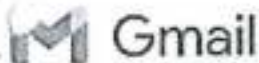

In the above context, the pointwise reply pertaining to this Institute is given below;

(a) The details of the action-plan formulated to improve the quality of the innovation and research based training being provided by the Cultural Institutions in the country -

Central Institute of Higher Tibetan Studies (CIHTS) was established in 1967 to preserve and promote the linguistic and cultural aspects of ancient classical languages of India and Tibet. To fulfil the given objectives, the Institute has created an ecosystem for innovation and creation to transfer the knowledge through restoration and translation, bringing forward the rare Buddhist texts and compiling references on different subjects of studies in the form of dictionaries. The creation of such incubation was first started in 1981 in the form of a restoration unit in the research department. When interest in Mahayana Buddhism began to rise worldwide, literature related to it was limited to classical languages like Tibetan and Chinese. As a result, three more departments were established - Translation, Rare Buddhist Text Research and Dictionary. Due to the efforts of scholars of these departments, many texts of ancient Indian science and literature preserved in the Tibetan language were restored into original Sanskrit, which were lost in its land of birth and translated into modern languages.

More than 200 titles were either restored, translated, critically edited or published. Many ancient Indian pieces of literature, hidden in ancient scripts such as Newari, Bhujimol, old Bangla, and Maithili etc. were transcribed into Devanagari to disseminate the knowledge to the present world. Simultaneously, the Institute undertook a grand dictionary project, in which there was a provision of the creation of the two kinds of lexicons- general and specialized.

Various translation and editing workshops are being organized to fulfil a few massive projects the Institute has undertaken to train young researchers. The variety of manuscripts, xylographs, microfilms and other ancient forms of documents brought from Tibet by Mahapandit Rahul Sanskrityayan are preserved in Patna Museum, Bihar. Most of the Mahayana Buddhist literature in this collection are in the Tibetan and Sanskrit languages. A strong need to translate and publish the critical text of the group in Hindi and English to make it accessible for Indian scholars and students was felt. To fulfil the massive task, an MoU is signed between the Institute and Patna Museum on 25th May 2018 to promote Buddhist Studies, preservation of literature, digitization of manuscripts, research of manuscripts and publication. Since then, the Institute has been providing high-quality research training and translating the texts.
